

## MINISTRY OF POWER

## PETROLEUM (PRODUCTION) ACT 1934

The Minister of Power hereby gives notice of the expiry of Prospecting Licence No. 183 granted under the provisions of the Petroleum (Production) Act 1934 and the Petroleum (Production) Regulations 1935, as amended, to BP Petroleum Development

Limited, Britannic House, Moor Lane, London E.C.2. The licence covered an area of 175 square miles in the county of Dorset.

A description of the boundaries of the area was published in the London Gazette dated 6th August 1965, and maps showing the boundaries may be inspected on application to the Ministry of Power, Petroleum Division, Thames House South, Millbank, London S.W.1.

## THE PETROLEUM (PRODUCTION) REGULATIONS, 1966

The Minister of Power hereby gives notice that in pursuance of the powers conferred upon him by section 2(1) of the Petroleum (Production) Act, 1934, and in accordance with the provisions of the Petroleum (Production) Regulations, 1966, he has granted to the persons named in the Schedule below production licences in respect of the landward areas respectively shown in the said schedule against the names of those persons.

Areas are bounded by lines drawn between grid points ascertainable with respect to the National Grid. Except where otherwise indicated in the Schedule, such boundaries are straight lines between the grid points named. Maps illustrating the boundaries are available for inspection at the Ministry's office at Thames House South, Millbank, London S.W.1.

Notice is hereby given that the Minister of Housing and Local Government in exercise of his powers under section 155 of the Town and Country Planning Act 1962, has made an Order extinguishing with

effect from the 23rd February 1968 the public rights of way over:

- (i) Part of Back Bowlby Street East being the part which starts at a point adjoining the northern boundary of No. 59 Bowlby Street and runs north-west for a distance of approximately 336 feet to a point adjoining the northern boundary of No. 27 Bowlby Street, including the unnamed junction running south-west from Back Bowlby Street (East) to Bowlby Street, adjacent to Nos. 57 and 59 Bowlby Street;
- (ii) Part of Bowlby Street being the part which starts at a point adjoining the south-western boundary of No. 59 Bowlby Street and runs
