

EPPING AND ONGAR RURAL DISTRICT COUNCIL

Rural District Council of Epping and Ongar (Kelvedon Hatch) Public Path Extinguishment Order, 1967.

Notice is hereby given that on the 7th day of February 1968, the Minister of Housing and Local Government confirmed with modification the above Order.

Its effect is to extinguish the following path:

The public footpath in the parish of Kelvedon Hatch, commencing on the western side of Ongar Road, Kelvedon Hatch (Brentwood/Ongar Road (A.128)) opposite St. Nicholas Church, in the north-western corner of Enclosure 194 and running in a south-easterly direction for a distance of approximately 550 feet, roughly parallel with Ongar Road, firstly in front of the properties known as Ka-Es-Ona, Timbers, Karenola, Red House, Copperfields, and numbers 18, 20, 22 and 24 Ongar Road, then alongside number 26 Ongar Road, and at the rear of numbers 30 and 32 Ongar Road, terminating where it joins the Lane known as "The Chase".

(All references to enclosure numbers are those shown on Ordnance Survey Essex (New Series) Sheet LX11.13 Edition of 1920 and Essex Sheet LXX1.1. Revision of 1939).

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Rural District Council Offices, 323 High Street, Epping, Essex, during normal office hours.

The Order becomes operative as from the 23rd August 1968, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.

NOTICE OF SUBMISSION OF A PUBLIC PATH ORDER

The Gipping Rural District Council (Combs Footpath No. 58 Part) Public Path Diversion Order, 1968

Notice is hereby given that the above Order, made on the 12th day of February 1968, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to divert that part of footpath No. 58 which starts at its junction with footpath No. 61 on the western boundary of O.S. field number 155 and runs in a north-easterly direction across the aforementioned field for a distance of approximately 188 yards to the northern boundary of the field, to a line running from the point at which footpath No. 58 crosses the northern boundary of O.S. field number 155 along the northern boundary of the field in a general westerly direction for a distance of approximately 103 yards to the north-western corner of the field where it will join footpath No. 61.
