Distributors' Margins in Relation to Manufacturers' Recommended Prices

On 21st December 1967, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs, the President of the Board of Trade and the Minister of

Agriculture, Fisheries and Food referred the question of Distributors' Margins in Relation to Manufacturers' Recommended Prices to the National Board for Prices and Incomes for examination.
