Borough of Hyde (School Entrances) (Prohibition of Waiting) Order, 1968

Notice is hereby given that the Hyde Borough Council has made an Order under subsections (1), (2) and (3) of section 1 and subsection (4) of section 2 of the Road Traffic Regulation Act, 1967, the effect of which is to provide that no person except upon the direction or with the permission of a police

upon the direction or with the permission of a police constable in uniform shall cause or permit the waiting of a vehicle in the lengths of road described in the Schedule hereto, between the hours of 8.30 a.m. and 4.30 p.m. on Mondays to Fridays inclusive. The Order which becomes operative on 18th March 1968, provides that a vehicle may wait for the following purposes: (a) to enable persons to board or leave the vehicle; (b) to enable goods to be loaded or unloaded; (c) to enable the vehicle to be used in connection with funeral or building operations; and (d) to enable omnibuses to operate special journeys to and from schools whose entrances special journeys to and from schools whose entrances are affected.
