The Trunk Roads (Various Roads, Holyhead)
(Restriction of Waiting) Order 1968

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which is to prohibit waiting between the hours of 8 a.m. and 7 p.m.:

- (a) on any of the sides of road or in either of the lengths of road specified in Schedule 1 to this notice; and
- (b) on either of the sides of road specified in Schedule 2 to this notice for a longer period than 30 minutes in any hour.

Exceptions are provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties. The proposed restrictions will not apply to a stage carriage or an express carriage.

SCHEDULE 1

Lengths and sides of the London—Holyhead Trunk Road (A.5), hereinafter referred to as "the trunk road", at Holyhead in the Urban District of Holyhead in the county of Anglesey.

1. The north side of that length of the trunk road, known as Marine Square.
2. The west side of that length of the trunk road, known as Marine Square, Stanley Crescent, Victoria Road and Church Terrace, which extends from a point 100 yards north-east of its junction with Cross Street to a point 32 yards south of its junction with Holborn Road, a distance of approximately 963 yards.
3. The south-east side of that length of the trunk road, known as Marine Square and Stanley Crescent, which extends from a point 6 yards south of its junction with Cross Street to a point 133 yards north of that junction, a distance of 139 yards.
4. The east side of that length of the trunk road, known as Victoria Road and Church Terrace, which extends from a point 260 yards north of its junction with Holborn Road to a point 43 yards south of that junction, a distance of 303 yards.
5. The east side of that length of the trunk road, known as Victoria Terrace, which extends from its junction with Victoria Road to a point 20 yards north-west of that junction.
6. That length of the trunk road, known as London Road, which extends from its junction with Church Terrace to its junction with Cecil Street, a distance of approximately 343 yards.
7. That length of the trunk road which extends from Victoria Road to Victoria Terrace, a distance of approximately 13 yards.
