CIVIL DEFENCE CORPS (REVOCATION) WARRANT 1968

- 1. The service of all members of the Civil Defence Corps shall, unless previously terminated, be terminated on 1st April 1968.
- 2. The following Warrants of the Secretary of State are hereby revoked, namely,

The Civil Defence Corps Warrant 1949;
The Civil Defence Corps (Sick Pay) Warrant 1963;
The Civil Defence Corps (Organisation and Bounty) Warrant 1967.

- 3. This Warrant may be cited as the Civil Defence Corps (Revocation) Warrant 1968.
- 4. Section 38 of the Interpretation Act 1889 shall apply as if this Warrant were an Act of Parliament and as if any Warrant revoked by this Warrant were an Act of Parliament repealed by an Act of Parliament. ment.
- 5. (1) Paragraph 2 of this Warrant shall come into force on 1st April 1968.

 (2) The remainder of this Warrant shall come into force forthwith.

The Trunk Roads (Various Roads, Holyhead) (Restriction of Waiting) Order 1968

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which is to prohibit waiting between the hours of 8 a.m. and 7 p.m.:

- (a) on any of the sides of road or in either of the lengths of road specified in Schedule 1 to this notice; and
 (b) on either of the sides of road specified in Schedule 2 to this notice for a longer period than
- 30 minutes in any hour.

Exceptions are provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties. The proposed restrictions will not apply to a stage carriage or an express carriage.

SCHEDULE 1

Lengths and sides of the London—Holyhead Trunk Road (A.5), hereinafter referred to as "the trunk road", at Holyhead in the Urban District of Holy-head, in the County of Anglesey.

- 1. The north side of that length of the trunk road, known as Marine Square.
- 2. The west side of that length of the trunk road, known as Marine Square, Starrley Crescent, Victoria
