Lieutenant Anthony Trevor BROOKE-WEBB (475106), Royal Regiment of Artillery.

On the 16th October 1967, Lieutenant Brooke-Webb was in charge of a party of 7 soldiers, including 5 recruits, at Sennybridge.

The party arrived in torrential rain at a disused building on the edge of the range about 1730 hours, where they were to spend the night pending the start of a battery exercise the following day.

Lieutenant Brooke-Webb instructed one of the trained soldiers to fill a No. 3 cooker with petrol in order to make tea. The soldier was unable to accomplish the task in the gale outside and moved inside the doorway of the building. Suddenly the jerrycan caught fire. The soldier was able to get outside without harm.

Lieutenant Brooke-Webb tried to kick the blazing jerrycan out of the building, but it spun round blazing in the doorway.

Two soldiers ran out from inside the building and were badly burned in the process. Lieutenant Brooke-Webb rolled them in the mud to extinguish their burning clothing and organised their removal to hospital.

It was then realised that one of the young soldiers was still inside the burning building. Lieutenant Brooke-Webb immediately rushed through the flames but was forced back after three attempts by choking fumes.

On the fourth attempt he located the soldier who was by now overcome by smoke, and although badly burned himself, Lieutenant Brooke-Webb succeeded in getting the soldier outside. He then stopped a passing civilian vehicle and in company with the soldier was driven to Bulth Wells hospital.

There he refused all help for himself until everything possible had been done for the soldier.

Lieutenant Brooke-Webb displayed outstanding courage and determination of a high order, and his quick presence of mind certainly saved the soldiers from further injuries and possible death.
