Those lengths of the Chester—Bangor Trunk Road (A.55), known as Abergele Road, at Old Colwyn, Colwyn Bay in the county of Denbigh, which extend:

- (a) from its junction with Victoria Road to a point 70 feet west of that junction; and
- (b) from its junction with Coed Coch Road to a point 75 feet south-east of that junction.

#### Y SWYDDFA GYMREIG

*The Newport—Worcester Trunk Road (A.40) (Prohibition of Waiting) (Clearways) (Wales) (No. 1) Order 1968*

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967 the effect of which is to prohibit (with certain exceptions) the waiting of vehicles on any of those main carriageways forming part of the length of road specified in the Schedule hereto.

The Order also prohibits trading from the verge of the main carriageways of that length of road.

The main carriageways comprised in that length of the Newport—Worcester Trunk Road (A.40), which lies in the County of Monmouth between a point 180 feet south-west of the centre of Dixton Roundabout and a point 2.89 miles south-west of the centre of the said Roundabout, a distance of approximately 2.86 miles.

#### TOWN AND COUNTRY PLANNING ACT 1962

The Secretary of State hereby gives notice that he has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (County of Glamorgan) (No. 11) Order 1968" authorising the stopping up of a length of footpath at Lan Wood, Pontypridd, Glamorgan, and requiring the provision of three new footpaths and other new highways.
