The QUEEN has been graciously pleased to approve the award of the George Medal to the undermentioned:

23222364 Sergeant James Hall MATCHETT, The Welch Regiment.

On Monday, 4th December 1967, Sergeant Matchett was in command of a patrol of the Reconnaissance Platoon, 1st Battalion, The Welch Regiment, visiting Pak Fu Shan Police Post on the Hong Kong/China

A party of Chinese policemen inadvertently entered the minefield which surrounded the post, and one policeman was severely injured when a mine exploded. policeman was severely injured when a mine exploded. A European Inspector was also severely injured while attempting, with the aid of Sergeant Matchett and other soldiers, to rescue the first man. Sergeant Matchett, although himself shaken and slightly injured by the second explosion, immediately took charge of the rescue operation.

After telling those in the minefield to remain absolutely still, he carefully worked his way to them, avoiding several mines on the way. He raised the least injured man to his feet and, after making sure he could walk led him step by step out of the mine-

He then returned through the minefield to the other injured a second and third time, making a further careful check of the area each time. He administered first aid to the two badly wounded policemen, each of whom had lost the lower part of his leg, and in turn carried them out of the minefield. field.

Throughout the incident Sergeant Matchett acted with complete disregard for his own safety, well knowing that one false step would result in very serious injury to himself and further injury to those already injured. His calm, unselfish and courageous conduct was in the highest traditions of the Service.
