Trunk Road (Various Roads, Rhayader) (Restriction of Waiting) Order, 1968

Notice is hereby given that the Secretary of State has made an Order under sections 1 and 3 of the Road Traffic Regulation Act, 1967, the effect of which is:

(1) to revoke the Trunk Road (Various Roads, Rhayader) (Restriction of Waiting) Order, 1960; and (2) to prohibit waiting between the hours of 8 a.m. and 8 p.m.:

(i) in any of the lengths of road or on the side of road specified in Schedule 1 to this notice; and

(ii) on the side of road specified in Schedule 2 to this notice for a longer period than 30 minutes in any hour.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties; or to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths of road or either of the said sides of road.

An exception has also been provided to enable a vehicle to wait for so long as may be necessary if it is a stage carriage or an express carriage.

Lengths and a side of the Cardiff-Langurig Trunk Road (A.44 and A.479) (hereinafter referred to as "the trunk road") at Rhayader in the County of Radnor.

- 1. That length of the trunk road, known as South Street, which extends from a point 90 feet south-east of its junction with Cae Herbert Lane to its junction with West Street.
- 2. That length of the trunk road, known as North Street, which extends from its junction with West Street to a point 40 feet north-west of that junction.
