Her Majesty, in exercise of the powers conferred on Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (28 & 29 Vict. c. 73), and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to

by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. This Order may be cited as the Naval Overseas Family Allowances Order 1968.

2. Overseas Family Allowances shall be payable by the Secretary of State to officers, ratings and other ranks of the Royal Navy and Royal Marines in respect of their families residing with them at a duty station abroad, in place of the allowances provided by the Family Allowances Act 1965 (1965 c. 53) which would otherwise be payable under that Act for would otherwise be payable under that Act for families in the United Kingdom.

3. The rates so payable as Overseas Family Allowances shall be those prescribed by or under the last-mentioned Act (as amended) and accordingly the allowances payable for periods after 8th April 1968 shall be those prescribed in the Family Allowances and National Insurance Act 1967

(1967 c. 90).

4. The following provisions shall cease to have

(a) paragraph 8 of Schedule III to the Order in Council (dealing with Naval Pay and Allowances) dated 27th April 1948;
(b) all the provisions of the Orders in Council (dealing with Naval Overseas Family Allowances) dated 21st July 1950 and 9th October 1956.

The Newport—Shrewsbury Trunk Road (Prohibition of Waiting) (Clearways) (Wales) (No. 1) Order 1968.

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which is to prohibit (with certain exceptions) the waiting of vehicles on any of those main carriageways forming part of the length of the trunk road specified in the Schedule hereto.

The Order also prohibits trading from the verges of the main carriageways of that length of road.
