Notice is hereby given that the Corporation of Hemel Hempstead in exercise of their powers under section 1 and section 28 (1) of the Road Traffic Regulation Act 1967 propose to make an Order the effect of which will be to:

- 1. Delete from the Borough of Hemel Hempstead (Traffic Regulation No. 1) Order 1963, reference to the prohibition of waiting between 8.30 a.m. and 6.30 p.m. in High Street (both sides) from the junction with Queensway to the south end of St. Mary's Close.
- 2. Delete from The Borough of Hemel Hempstead (Vehicle Parking Places) Order 1963 the parking places for thirteen private cars on the west side of High Street between Chapel Street and Cherry
- Bounce and the parking places for nineteen vehicles in St. Mary's Close.
  Designate St. Mary's Close as a parking place for ten vehicles for a period of one hour in two hours between 8.30 a.m. and 6.30 p.m. (Mondays to Saturdays).
- 4. Prohibit waiting between 8.30 a.m. and 11 p.m.

Proniot waiting between 8.30 a.m. and 11 p.m. on all days of the week in the High Street (west side) from Queensway to Fletcher Way.
 Prohibit waiting for more than one hour in every two consecutive hours between 8.30 a.m. and 6.30 p.m. (Mondays to Saturdays) in the following lengths of High Street (east side):
 (a) From a point 5 mode south of the

(a) From a point 5 yards north of the centre line of Chapel Street to a point 4 yards south of the northern boundary of No. 85 High Street;

(b) From a point opposite the southern boundary of No. 95 High Street to a point opposite the northern boundary of No. 97 High Street

(c) From a point opposite the southern boundary of No. 103 High Street to a point opposite the northern boundary of No. 105 High Street

(d) From a point 12 yards north of the centre line of Cherry Bounce to a point 3 yards north of the northern boundary of No. 109 High Street.

6. Prohibit waiting between 8.30 a.m. and 11 p.m. (all days) in High Street (east side) from Queens-way to Chapel Street and from No. 85 High Street to Fletcher Way excluding lengths of High Street referred to in 5 above.

- Prohibit any vehicle to wait between 8.30 a.m. and 6.30 p.m. (Mondays to Saturdays) in Mill Street (south-east side) for a distance of approxi-mately 50 yards from the junction with London Road
- 8. Require the driving of vehicles in Chapel Street (from the junction with High Street for a distance of 38 yards in the direction of Allandale) to proceed in an easterly direction from the High
- Street only. 9. Prohibit the driving of cycles on the footpath between Orchard Close and Nicholas Way.

Nothing in the proposed Order shall prevent a person from causing or permitting a vehicle to wait in any of the restricted areas for loading and unloading goods, when acting under police direction; for boarding or alighting or in connection with building operations, furniture removal, postal delivery. There are also savings for disabled persons, funerals and hackney carriages.
