*Pewsey Rural District (Fittleton Footpath No. 4)
Extinguishment Order, 1968*

Notice is hereby given that the above Order made on the 14th day of August 1968, is about to be submitted to the Minister of Housing and Local Government for confirmation, or to be confirmed by the Council as an unopposed Order.

Its effect will be to extinguish the public right of way running from unclassified road 8083 in a south-westerly direction along the northern boundary of O.S. Parcel No. 90 (Wilts XLVII.11—1939 Edition) for a distance of 97 yards or thereabouts to Footpath No. 3 in the Parish of Fittleton.

SUBMISSION OF PUBLIC PATH ORDER

*The Skipton Rural District Public Path Diversion
Order No. 1 1968*

Notice is hereby given that the above Order made on the 20th January 1968, is about to be submitted to the Minister of Housing and Local Government for confirmation.

Its effect will be to divert part of the public right of way leading from Carseylands Hill, Eshton in the vicinity of Newfield Bridge so that the public path will not pass directly across the field O.S. number 68. That part of the path, running from Carseylands Hill at a point 33 yards due east of Newfield Bridge in a northerly direction for a distance of 313 yards to a point approximately 60 yards due west of Newfield Laithe on the said field boundary, will be extinguished; and a new length of public footpath will be created, running from that point on Carseylands Hill 33 yards due west of Newfield Bridge in a north-westerly direction (for some 52 yards) to the weir on the River Aire, then in a northerly direction for approximately 350 yards to a point where it will join the existing footpath approximately 60 yards due west of Newfield Laithe on the said field boundary.

A copy of this Order and the map contained in it has been deposited at the Council Offices, Granville Street, Skipton, and may be inspected free of charge between 10 a.m. and 5.15 p.m. on any weekday.

CONFIRMATION OF PUBLIC PATH ORDER

*Warrington Rural District Council Public Path
Diversion Order No. 1 1968*

Notice is hereby given that on the 14th day of August 1968, the Minister of Housing and Local Government confirmed, with modifications, the above Order.

Its effect will be to divert part of the existing path No. 3 in the Parish of Winwick as shown on the map attached to the Order commencing at a point "A" on the south side of the M.6 Motorway, approximately 400 yards west of Southworth Lane Bridge proceeding to a point "B" on the map, a distance of 400 yards west-north-west of point "A"; to a line commencing at the same point marked "A" on the south side of the M.6 Motorway, approximately 400 yards west of the Southworth Lane Bridge to a point marked "C" which is situate parallel to the south side of the M.6 Motorway a distance of 400 yards from point "A" at the junction with path No. 3A.

The old path will be closed on and after the 30th day of August 1968.

A copy of the confirmed Order and the map contained in the Order has been deposited at the Council Offices, Museum Street, Warrington and will be open for inspection, free of charge, between the hours of 9 a.m. and 5.30 p.m. Mondays to Fridays.

The Order becomes operative as from the 23rd day of August 1968, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act 1959, or on the grounds that any requirement of the Act or any Regulation made thereunder has not been complied with in relation to the approval of the Order, he may within six weeks from the date of publication of this notice make application to the High Court.
