Job Evaluation Schemes

On 23rd March 1967, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the First Secretary of State and the Minister of Labour referred to the National Board for Prices of Labour referred to the National Board for Frices and Incomes for examination the question of job evaluation schemes. The Board has now made its report entitled "Job Evaluation". In accordance with section 5 (1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity hereby gives notice that the report was first published as Command Paper No. 3772 on 26th September 1968.

A series of voluntary agreements and complementary Wages Council settlements have been reached in the clothing manufacturing industries. These have been implemented since March 1968, or are in course of implementation. The Government considers that an implementation.
