PRICES AND INCOMES ACT 1966 REPORT BY THE NATIONAL BOARD FOR PRICES AND INCOMES

Pay of Certain Workers employed in the Thermal Insulation Contracting Industry

On 16th August 1968, in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity referred to the National Board for Prices and Incomes for their report the settlement reached on 25th January 1968 by the National Joint Council for the Thermal Insulation Contracting Industry providing for increases in the hourly rates of wages of thermal insulation engineers, labourers over 18 years of age and apprentices employed in the thermal insulation contracting industry. The Board has now made its report entitled "Report on a settlement relating to the pay of certain workers employed in the Thermal Insulation Contracting Industry." In accordance with section 5(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity hereby gives notice that the report was first published as Command Paper Number 3784 on 8th October 1968.
