WAITING RESTRICTIONS

*London Borough of Merton*

Notice is hereby given that the Greater London Council are about to consider a proposal that they should make an Order under section 6 of the Road Traffic Regulation Act 1967, the effect of which would be, in the London Borough of Merton, to impose restrictions on waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:

*Haydon's Road*, between a point opposite the party wall of Nos. 285 and 287 Haydon's Road and the northern kerbline of All Saints' Road.

The restrictions would also apply to the first 60 feet of all adjoining side roads with the exception of All Saints' Road.
