The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 3 (6) and 13 of the Import Duties Act 1958, viz.:

The Import Duties (Temporary Exemptions) (No. 5) Order, 1968.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 1st January 1969.

The Order comes into operation on 7th November 1968 and has been published as Statutory Instruments 1968 No. 1721.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 9 and 13 of, and Schedule 5 to, the Import Duties Act, 1958, and section 2 (5) of the Finance Act, 1965, viz.:

The Import Duty Drawbacks (No. 9) Order, 1968.

This Order:

- (1) provides for the allowance of drawback of import duty on certain glider parts when exported as parts of complete gliders;
- (2) amends the definition of certain goods by reference to their Tariff classification consequent upon the revision of the Tariff heading concerned (92.13);
- (3) varies the rates of drawback of import duty on electro-sensitive recording paper;
- (4) revokes the fixed rates of drawback of import duty on the following exported goods manufactured from the materials shown and provides for drawback to be related to the duty paid on the quantity of imported material actually used in their manufacture:

| <i>Exported goods</i>            | <i>Imported materials</i>     |
|----------------------------------|-------------------------------|
| Golf clubs                       | Unfinished wooden head blocks |
| Panama hats                      | Straw hoods                   |
| Processed textile waste and yarn | Certain textile fibre         |
