Distributors' Costs and Margins on Furniture, Domestic Electrical Appliances and Footwear

On 15th August 1967, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act, 1966, the First Secretary of State, the Board of Trade and the Minister of Technology referred to the National Board for Prices and Incomes for examination the question of the distributors' costs and margins on furniture, domestic electrical appliances and footwear. Pay of University Teachers in Great Britain

On 2nd November 1967, in pursuance of their powers under section 3 (2) of the Prices and Incomes Act, 1966, the Secretary of State for Economic Affairs and the Secretary of State for Education and Science instructed the National Board for Prices and

Incomes to keep under continuous review the remuneration of the academic staff of universities in Great Britain. The Board has now made its first report entitled "Standing Reference on the Pay of University Teachers in Great Britain". In accordance with section 5 (1) of the Prices and Incomes Act, 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Secretary of State for Education and Science hereby give notice that the report was first published as Command Paper Number 3866 on 18th December 1968. 1968.

PRICES AND INCOMES ACT, 1966

Reference to the National Board for Prices and Incomes withdrawing the reference of a settlement affecting certain workers employed in the Building Industry; and Notice of revocation of the direction under Section 15 of the Prices and Incomes Act, 1966, in relation thereto.
