The Trunk Road (London Road, Chelmsford) (Pro-hibition of Right-hand Turn) Order 1968

The Minister of Transport has made an Order under section 1 of the Road Traffic Regulation Act 1967 section 1 of the Road Traffic Regulation Act 1967 the effect of which is to prevent vehicles being driven northwards in that length of the London—Great Yarmouth Road (A.12) known as London Road in the Borough of Chelmsford from making a right-hand turn into Widford Road.

The Trunk Road (South Street and Tout Hill, Wincanton) (Prohibition and Restriction of Waiting) Order, 1968.

The Minister of Transport has made an Order under sections 1 and 3 of the Road Traffic Regulation Act 1967, the effect of which is to revoke the prohibition of waiting on that length of the London—Penzance Trunk Road (A.303) known as South Street and Tout Hill which lies between Market Place and Balsam Fields in the Rural District of Wincanton in the County of Somerset and to re-enact it with a modification to allow waiting for a period not exceeding 30 minutes in any hour on the north-east and east side of the said length from a point 260 feet north of its junction with Balsam Fields to a point 60 feet north of that junction.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction or traffic the maintenance of the road or the services to traffic, the maintenance of the road or the services

therein.

The Trunk Road (Various Roads, Morley) (Restriction of Waiting) Order

The Minister of Transport proposes to make an Order under sections 1 and 3 of the Road Traffic Regulation Act 1967 the effect of which will be to prohibit any person from causing or permitting any prohibit any person from causing or permitting any vehicle to wait between the hours of 9 a.m. and 11 p.m. in any of the lengths of road or on the side of road specified in the Schedule to this notice. The Order re-enacts with amendments the provisions contained in the Trunk Road (Various Roads, Morley) (Prohibition of Waiting) Order 1968 by reducing the period during which waiting is prohibited from 24 hours to 14 hours, and extending for short distances the lengths and side of road described in paragraphs 1, 2 and 3 and 6 of the Schedule. Schedule.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

SCHEDULE 1

Length and side of the Norman Cross—Grimsby Trunk Road (A.16) hereinafter referred to as "the trunk road".

1. That length of the trunk road, known as High Street in the Borough of Boston, which extends from its junction with Emery Lane to a point 20 yards south of its junction with Oxford Street, a distance of approximately 573 yards.

2. The west side of that length of the trunk road, known in part as Strait Bargate and in part as Wide Bargate in the said Borough, which extends from a point 4 yards south of the junction of Strait Bargate and Wide Bargate in a general northerly direction for a distance of 17 yards.
