Road Traffic Regulation Act 1967—Section 12 Notice is hereby given that the Secretary of State intends to make an Order the effect of which will be to close to vehicular traffic that length of the

Fishguard—Bangor Trunk Road (A.487) from its junction with Dinas Terrace to its junction with Spring Gardens passing under Trefechan Railway Bridge, which carries the disused Aberystwyth— Lianrhystyd Road railway line, in the Borough of Aberystwyth in the County of Cardigan. This Order, to be made by reason of demolition work to be carried out on the bridge, will be in operation from 11.30 p.m. on Saturday, 18th January until 12 moon Sunday, 19th January 1969.

#### The Trunk Road (Aber Road and Penmaenmawr Road, Llanfairfechan) (Prohibition of Waiting) Order 1968.

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which is to prohibit the waiting of any vehicle in the length of road specified in the Schedule below.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.
