*The County of the West Riding of Yorkshire (Various Roads at Elland) (Restriction of Waiting) Order, 1969*

Notice is hereby given that the County Council of the West Riding of Yorkshire propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act, 1967, the effect of which will be to restrict the waiting by vehicles between the hours of 8 a.m. and 11 p.m., Mondays to Saturdays inclusive, on the sides of road and lengths of road specified in the Schedules to this notice, and also to prohibit loading and unloading between the hours of 8 a.m. and 6 p.m., Mondays to Saturdays inclusive, on the sides of road specified in Schedule 2 to this notice at Elland in the Elland Urban District.

Exemptions are provided in the Order to enable a person to board or alight from or cause goods to be loaded onto or unloaded from a vehicle, or to enable a vehicle to be used in connection with certain building operations, roadworks or works of statutory undertakers.

A copy of the proposed Order and a map showing the roads to which the proposed Order relates may be inspected during normal office hours at the offices of (i) the County Council of the West Riding of Yorkshire (Room 87), County Hall, Wakefield, and (ii) the Elland Urban District Council, Council Offices, Elland.

*Lengths and sides of lengths of road in the Elland Urban District*

*The Sowerby Bridge and Greetland (Class I) County Road A.6026 (locally known as Stainland Road).* On the north-west side from its junction with Saddleworth Road to its junction with Rochdale Road.

*The Buckstones and Brighouse (Class I) County Road A.6025 (locally known as Saddleworth Road).* On the north side from a point 50 yards west of its junction with Stainland Road to its junction with Elizabeth Street.

*The Outlane and Greetland (Class II) County Road B.6112 (locally known as Stainland Road).* On the south side from a point 42 yards west of its junction with Stainland Road to its junction with Victoria Street.

*The Ripponden and Greetland (Class II) County Road B.6113 (locally known as Rochdale Road).* On the north-west side from its junction with Saddleworth Road for a distance of 240 yards in a south-westerly direction.

*Queen Street*  
*Middle Dean Street*  
*Dean Street*  
*Elizabeth Street*  
*Green Lane* On both sides from a point 45 yards north-west of its junction with Stainland Road to its junction with Alfred Street.

On both sides from their junctions with Stainland Road for a distance of 30 feet in a south-easterly direction.

*Sides of road in the Elland Urban District*

*The Sowerby Bridge and Greetland (Class I) County Road (locally known as Stainland Road).* On the south-east side from its junction with Rochdale Road for a distance of 30 feet in a south-westerly direction.

On the south-east side from its junction with Saddleworth Road for a distance of 40 feet in a north-easterly direction.

*The Outlane and Greetland (Class II) County Road (locally known as Stainland Road).* On the south-east side from its junction with Saddleworth Road for a distance of 75 feet in a south-westerly direction.

*The County of the West Riding of Yorkshire (Bradbury Lane, Greenfield) (Prohibition of Waiting) Order, 1969.*

Notice is hereby given that the County Council of the West Riding of Yorkshire propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act, 1967, the effect of which will be to permit the waiting by vehicles on both sides of that length of Bradbury Lane which extends from its junction with Banks Lane for a distance of 400 yards, at Dove Stones, Greenfield in the Saddleworth Urban District.

Exemptions are provided in the Order to enable a person to board or alight from or cause goods to be loaded onto or unloaded from a vehicle, or to enable a vehicle to be used in connection with certain building operations, road works or works of Statutory Undertakers.

A copy of the proposed Order, and a map showing the extent of the restrictions to be imposed on the length and sides of road to which the pro-

posed Order relates may be inspected during normal office hours at the offices of (i) the County Council of the West Riding of Yorkshire (Room 87), County Hall, Wakefield and (ii) the Saddleworth Urban District Council, Council Offices, St. Chads, Upper-mill, Near Oldham, Lancs.
