

to be used in the service of a local authority in pursuance of statutory powers or duties.

The time limit will not apply to an invalid carriage; a vehicle issued to a disabled person by the Government in lieu of an invalid carriage; a vehicle left by a driver who because of severe physical disability has been issued with an exemption by Colwyn Bay Borough Council and such exemption is displayed on the vehicle in a prominent position; or a vehicle left by a driver who has been issued with a yellow car badge by any local authority under the disabled drivers' scheme and the badge is placed in a conspicuous position on the vehicle.

The restrictions will not apply to a stage carriage or an express carriage.
