Y SWYDDFA GYMREIG**TOWN AND COUNTRY PLANNING ACT 1962**

The Secretary of State hereby gives notice that he has made an Order under section 153 of the above Act entitled "The Diversion of Highways (County of Flint) (No. 1) Order 1969" authorising the diversion of a length of footpath at Marian Bach, near Babel, Holywell, Flintshire, and involving the provision of a new footpath.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 23rd January 1969 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
