Notice is hereby given that the Minister of Housing and Local Government has reviewed his proposed modifications to the proposals for alterations and additions to the Derbyshire County Development Plan submitted by the Council on 12th October 1960 and relating to land in Dronfield Urban and Chesterfield Rural Districts and proposes to make the following additional modification:

Description of Modification	Modification Reason for
Delete all green belt notations in the town map and in the programme map, and all reference to green belt in the written statement.	So as not to prejudice the proposed Nottinghamshire / Derbyshire Sub-Regional Study.

Chesterfield Town Map

Notice is hereby given that on the 28th November 1968, the Minister of Housing and Local Government amended the above development plan.

Certified copies of extracts of the amended development plan have been deposited at the places mentioned below, and may be inspected free of charge by all interested persons during normal office hours on Mondays to Fridays inclusive:

The amendment becomes operative as from the 24th January 1969, but if any person aggrieved by it desires to question the validity thereof or any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act, 1962, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the making of the amendment, he may, within six weeks from the 24th January 1969 make application to the High Court.

The proposals dealt with in the amendment comprise the Town Map for Chesterfield and a new part to the approved Written Statement for the County Development Plan.

HEMEL HEMPSTEAD RURAL DISTRICT COUNCIL

TOWN AND COUNTRY PLANNING ACT, 1962

Notice is hereby given that the Rural District Council of Hemel Hempstead acting under delegated powers for the Hertfordshire County Council in pursuance

of the powers conferred upon the County Council by Article 4 of the Town and Country Planning General Development Order, 1963, and all other powers enabling them in that behalf have given a Direction entitled the Hemel Hempstead Rural District Council (Town and Country Planning) (Direction restricting permitted development) (Great Gaddesden) Order, 1968, and dated the 4th June 1968 (hereinafter called "the said Direction") directing that permission granted by Article 3 of the Town and Country Planning General Development Order, 1963, shall not apply to any development specified in the First Schedule hereto in the areas specified in the Second Schedule hereto.

The said Direction was approved by the Minister of Housing and Local Government on the 9th January 1969 and will come into force on the 24th January 1969.

FIRST SCHEDULE

The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture, other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings, being development comprised within paragraph one of Class VI referred to in the First Schedule to the said Order and not being development comprised within any other Class.

The areas situate in the Rural District of Hemel Hempstead shown coloured green on the plan attached to the said Order.

Norwich Fringe Area Town Map

Notice is hereby given that the Minister of Housing and Local Government has considered the proposals for alterations and additions to the Norfolk County Development Plan submitted by the Council on the 1st March 1966, and relating to land in the Norwich Fringe Area within the Rural Districts of Blofield and Flegg, Forehoe and Henstead, and St. Faith's and Aylsham and proposes to amend the Plan accordingly, subject to a number of modifications to the proposals.
