Public Path Extinguishment Order 1969*

Notice is hereby given that the above Order made on the 24th day of January 1969 is about to be submitted to the Ministry of Housing and Local Government for confirmation or to be confirmed by the Sedgefield Rural District Council as an unopposed Order.

Its effect will be to extinguish part of the public right of way (Footpath No. 16) running from Spring Lane, Sedgefield, to the Public Highway A.177, the part to be extinguished being a length commencing at the south-east corner of the Sedgefield Junior School Playingfield and proceeding in a south-easterly direction for a distance of 307 yards or thereabouts.

The Sedgefield Rural District Council is satisfied that a suitable alternative right of way will be provided over adjoining land as specified in the Order.
