The Civil Service Commissioners hereby give notice that the following Regulation comes into force forthwith:

RECERTIFICATION REGULATION

By virtue of the powers conferred on them by Article 3 of the Civil Service Order in Council, 1956, as amended by the Civil Service (Amendment) Order in Council, 1964, Her Majesty's Civil Service Commissioners (hereinafter called "the Commissioners"), after consultation with Her Majesty's Secretary of State for Foreign and Commonwealth Affairs, hereby make the following regulation: make the following regulation:

A person who has received a permanent appointment and who holds such an appointment may not be transferred or promoted within Her Majesty's Home Civil Service or Diplomatic Service or otherwise receive a further permanent appointment therein without the issue of a further certificate of qualification if it is proposed that—

(1) he should be transferred from Her Majesty's Home Civil Service to Her Majesty's Diplomatic Service (or vice versa) in circumstances other

Home Civil Service to Her Majesty's Diplomatic Service (or vice versa) in circumstances other than those defined in Articles 2, 3 and 4 of the Diplomatic Service Order, 1964: provided that, if it is hereafter proposed that particular functions should be transferred from Her Majesty's Home Civil Service to Her Majesty's Diplomatic Service or vice versa, and that the persons employed on those functions should be similarly transferred, the Commissioners may at their discretion dispense with the issue of a further certificate of qualification in respect of a person so transferred for whom such a certificate would otherwise be required; otherwise be required;

(2) having been employed by virtue of a Limited Period certificate of qualification, he should be appointed in an established capacity;
(3) having been employed by virtue of a Restricted (Health) certificate of qualification, he should be appointed in an established capacity; provided that if he is so employed he may be so appointed without the issue of a further certificate of qualification if either (a) he has completed twenty years of qualifying service before attaining the age of sixty, or (b) he has completed five years
