BAILDON URBAN DISTRICT COUNCIL

The Baildon No. 11 Smoke Control Order, 1969

Notice is hereby given that the Baildon Urban District Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 on the 28th day of January 1969, made an Order entitled the Baildon No. 11 Smoke Control Order, 1969, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st day of November 1969, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected free of charge at the office of the Clerk of the Council, Town Hall, Baildon, at all reasonable times during the period of six weeks from the 6th day of February 1969.

Within the said period any person who will be affected by the Order may by notice in writing to The Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

Description of Smoke Control Area No. 11

An area in the south-east of the district lying between the river boundary and Southdown Road, Otley Road and the railway lines (excluding Smoke Control Areas Nos. 4 and 5).

The City of Leeds No. 76 Scott Hall (Newton Lodge) Smoke Control Order 1969

Notice is hereby given that the Lord Mayor, Aldermen and Citizens of the City of Leeds acting by the Council for the said City in exercise of the powers conferred upon them by section 11 of the Clean Air Act, 1956 on the 22nd January 1969 made an Order entitled "The City of Leeds No. 76 Scott Hall (Newton Lodge) Smoke Control Order, 1969," declaring the area described in the Schedule hereto

to be a Smoke Control Area which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 0s. 0d. unless he proves that the emission of smoke was not caused by the use of any fuel other than the authorised fuel. The authorised fuels include anthracite, coke, and other carbonised fuels, gas and electricity.

In addition as from the 1st April 1969 in accordance with the Clean Air Act, 1968, section 9 (1) Any person who—

- (a) acquires any solid fuel, other than an authorised fuel, for use in a building in a smoke control area otherwise than in a building or fireplace exempted from the operation of section 11 of the principal Act; or
- (b) acquires any solid fuel, other than an authorised fuel, for use in a boiler or plant to which this paragraph applies in a smoke control area, not being a boiler or plant so exempted; or
- (c) sells by retail any solid fuel other than an authorised fuel, for delivery by him or on his behalf to a building in a smoke control area or to premises in such an area in which there is a boiler or plant to which paragraph (b) above applies;

shall be liable on summary conviction to a fine not exceeding £20.

If confirmed, the Order will not come into operation before the 1st day of December 1969, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the plan referred to therein may be inspected, free of charge, at the office of the undersigned, Room No. 47, Town Clerk's Department, Civic Hall, Leeds 1, at all reasonable times during the period of six weeks from the 7th February 1969.

Within the said period any person who will be affected by the Order may, by notice in writing to the Secretary, Minister of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.
