

he found Major Skelton and a man fighting in the road near by, and saw that the man was armed with a knife. On closing with the man Major Clifford was struck a blow with the knife in his left side, wounding him to such an extent that the aggressor was able to make good his escape.

The two officers and the girl who had been assaulted, were taken to hospital where they were detained.

Major Clifford's brave action and complete disregard for his own personal safety in assisting Major Skelton against an armed man was in the highest tradition of the Service.
