## PRESTON COUNTY BOROUGH COUNCIL

*The County Borough of Preston (Box Junctions) (No. 1) Order, 1969*

Notice is hereby given that the Council of the County Borough of Preston, in exercise of their powers under section 1 (1), (2) and (3) and section 2 (4) of the Road Traffic Regulation Act, 1967, have made an Order the effect of which is that as from the 17th March 1969 (and subject to certain exceptions) no person shall drive a vehicle into a boxed area and thereafter drive it in such a direction that it becomes necessary owing to the presence of stationary vehicles for any part of the vehicle to remain at rest within the area. The boxed areas referred to in the Order are areas of the carriageways of the following road junctions:

Church Street—Lancaster Road; Lancaster Road—Harris Street; Blackpool Road—Garstang Road; Fishergate—Chapel Street; and Fishergate—Corporation Street.

*The County Borough of Rotherham (Link Road—Drummond Street By-Pass) (Prohibition of Driving and One-Way Traffic) Order, 1969.*
