TOWN AND COUNTRY PLANNING ACT 1962 *Andover, Hants*

The Minister of Transport hereby gives notice that he proposes to make an Order under section 153 of the above Act to authorise the diversion of a length of the footpath known as Penny Path, off Broad Lane, Monxton, Andover, Hants, to enable residential development to be carried out in accordance with planning permission granted to Mrs. Miller.

The proposed Order will require that the new footpath to be provided as the diversion is to be a highway maintainable at the public expense, for which the highway authority is to be the Hampshire C.C.
