The Swinton and Pendlebury No. 6 Smoke Control Order 1969

Notice is hereby given that the Council of the Borough of Swinton and Pendlebury in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, on the 24th February 1969, made an Order entitled the Swinton and Pendlebury No. 6 Smoke Control Order 1969, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order, including the exemptions referred to in paragraph 7 below, and by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a
