

- of the United States of America, and has passed in the United Kingdom, or in such other country as the Council may direct in any particular case, such oral and/or written examinations in professional practice and practical experience in architecture as may from time to time be held by the Board for this purpose by virtue of Section 6 (4) of the principal Act; or any other examination in professional practice and practical experience in architecture which is for the time being recognised by the Council under Section 6 (1) (c) of the principal Act; or
- (iv) that his name has been previously removed from the Register under Section 3 (3) (a) of the principal Act, and he has at the time of the said removal paid all fees due and outstanding and any penalty payable under Section 13 (5) of the principal Act, and it is fit and proper that the applicant should be re-registered having regard to the circumstances which gave rise to his name being previously removed from the Register; or
- (v) that this application is both (a) supported by a resolution passed by the Council of one of the bodies referred to in paragraph 1, subparagraphs (i), (ii), (iii), (iv) or (v) of the First Schedule to the principal Act or by all the elected representatives referred to in sub-paragraph (vii), and (b) recommended for acceptance at a meeting of the Admission Committee at which not less than 15 members are present provided that not more than two members vote against the application or abstain from voting."

2. Add a new Regulation, to be numbered 27, as follows:

"27. Further, a person shall be eligible for registration under Section 6 (1) (d) of the principal Act if he is in the Council's opinion a fit and proper person to be registered and satisfies all of the requirements set out below:

- (i) that at the time of his application he has passed examinations in architecture in a country outside the United Kingdom which are in the opinion of the Council, equivalent in standard and scope to the examinations recognised by the Council under Section 6 (1) (c) of the principal Act; and
- (ii) that he has passed, in the United Kingdom or in such other country as the Council may direct in any particular case, such oral and/or written examinations in professional practice and practical experience in architecture as may from time to time be held by the Board for this purpose by virtue of Section 6 (4) of the principal Act; or any other examination in professional practice and practical experience in architecture which is for the time being recognised by the Council under Section 6 (1) (c) of the principal Act."

3. Amend Regulation 36 to read as follows, and re-number as 37:

"37. On applications for registration under Section 6 of the principal Act and Section 2 of the Architects Registration Act 1938, the fees shall be as follows:

- (a) £1, on an application made pursuant to Section 6 (1) (c) of the principal Act or to Regulation 26 (i), (ii), (iv) or (v). The said fee shall be paid by the applicant at the time of his application, but shall be repaid to him in the event of his application being refused;
- (b) £25, on an application made pursuant to Regulation 26 (iii) or Regulation 27. The said fee shall be paid by the applicant at the time of his application, and no part thereof shall be repayable to the applicant, whether or not the application is refused, unless the Council in its complete discretion shall in any particular case resolve to repay any part thereof;
- (c) £5, in addition to the £1 mentioned respectively in paragraph (a) and the £25 in paragraph (b) payable by any applicant who sits an examination in professional practice and practical experience as may from time to time be held by the Board by virtue of Section 6 (4) of the principal Act."

4. Re-number existing Regulations in consequence of the amendments above.
