The Trunk Road (Conway Road, Colwyn Bay) (Prohibition of Waiting) Order 1969

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which is to prohibit waiting between the hours of 8 a.m. and 7 p.m. on any of the sides of road specified in the Schedule to this Notice.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be Toaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties, or if the vehicle is a stage carriage or an express carriage.

#### SCHEDULE

Sides of the Chester-Bangor Trunk Road (A.55) (hereinafter referred to as "the trunk road"), in the Borough of Colwyn Bay in the County of Denbigh.

- The south-east side of that length of the trunk road, known as Conway Road, which extends from its junction with Victoria Park to its junction with Grosvenor Road, a distance of approximately 320 vards.
- 2. The north-west side of that length of the trunk road, known as Conway Road, which extends from its junction with Brompton Avenue to a point 30 yards north-east of that junction.
- 3. The north side of that length of the trunk road, known as Conway Road, which extends from its junction with Carlton Road to its junction with Princes Drive, a distance of approximately 65 yards.

The Trunk Road (Conway Road, Colwyn Bay) (Restriction of Waiting) (Experimental) Order 1969

Notice is hereby given that the Secretary of State has made an Order under section 9 of the Road Traffic Regulation Act 1967, the effect of which is to restrict the waiting of any vehicle between the hours of 8 a.m. and 7 p.m. on the side of road specified below for a longer period than 45 minutes in any 2 hours.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

The time limit does not apply to an invalid carriage; a vehicle issued to a disabled person by the Government in lieu of an invalid carriage; a vehicle left by a driver who because of severe physical disability has been issued with an exemption by Colwyn Bay Borough Council and such exemption is displayed on the vehicle in a prominent position; or a vehicle left by a driver who has been issued with a yellow car badge by any local authority under the disabled drivers' scheme and the badge is placed in a conspicuous position on the vehicle.

The restrictions do not apply to a stage carriage or an express carriage.
