Road, Tanerdy Side Road) Order 1969*

The Secretary of State hereby gives notice that, in relation to the above-mentioned Trunk Road at Tanerdy in the County of Carmarthenshire, he has made under section 9 of the above Act an Order which will authorise the Secretary of State to carry out improvements to Reservoir Road at Tanerdy aforesaid.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1959 or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may within six weeks from 18th April 1969 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
