BILLS RECEIVING ROYAL ASSENT

17th April 1969.

This day in accordance with the provisions of section 1 (1) (b) of the Royal Assent Act, 1967, there was notified to each House of Parliament sitting separately Her Majesty's Assent to:

Representation of the People Act, 1969. (c. 15.) Derby Corporation Act, 1969. Bournemouth Corporation Act, Coventry Corporation Act, 1969. Northampton County Council Act, 1969. Chelsea College, University of London Act, 1969.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 40 (2) of the Finance Act, 1967, viz.: The Income Tax (Interest on Unpaid Tax) Order,

1969

This Order increases, from 4 per cent. to 6 per cent. per annum, the rate of interest chargeable on overdue income tax (including surtax), corporation tax, capital gains tax, profits tax, excess profits tax and excess profits levy (other than tax charged for the purpose of making good to the Crown a loss attributable to fraud, wilful default or neglect). The increase applies from 19th April 1969, whether or

not interest runs from 19th April 1969, whether or not interest runs from before that date.

The Order comes into operation on 19th April 1969, and has been published as Statutory Instruments 1969 No.

SALARY STRUCTURES

Direction under section 5 (4) further extending the period within which the National Board for Prices and Incomes must publish their report

1. Whereas the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under section 2 (1) of the Prices and Incomes Act 1966, referred the above mentioned question to the National Board for Prices and Incomes for examination and has published the text of the reference in the Gazette on 25th July

text of the reference in the Gazette on 25th July 1968;

2. And whereas by section 5 (3) of the Act, but subject to section 5 (4), the Board are required to make their report so as to allow publication within three months of the said date;

3. And whereas, in pursuance of her powers under the said section 5 (4), the First Secretary of State and Secretary of State for Employment and Productivity, by a direction published in the Gazette on 24th October 1968, extended the said period of three months by six months: months by six months;

4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under the said section 5 (4), hereby directs that the said period of three months be further extended by three months.
