### TOWN AND COUNTRY PLANNING ACT 1962

*Bexley, Kent*

The Minister of Transport hereby gives notice that he has made an Order under section 153 of the above Act entitled "The Stopping Up of Highways (London Borough of Bexley (No. 1) Order 1969" authorising the stopping up of parts of the footways and verges at the junctions of Danson Road and East Rochester Way, Bexley, Kent.

Copies of the Order may be obtained, free of charge, on application to the Ministry of Transport, St. Christopher House, Southwark Street, London, S.E.1, (quoting HLL 70/L18/09) and may be inspected at all reasonable hours at the Town Hall, Erith, Kent.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may within 6 weeks of the 5th June, 1969 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
