The effect of this will be that as from 1st August 1969, with certain exceptions, no premises in the Rural District of Devizes, shall be used for dancing, music or any other entertainment of the like kind which is not public, within the meaning of the Public Health Acts Amendment Act, 1890, but which is promoted for private gain except under and in accordance with the terms of a licence granted under the 1967 Act, by the licensing Justices for the area in which the premises are situated.

EAST SUSSEX COUNTY COUNCIL

Borough of Hove Civic Amenities Act, 1967 Conservation Areas

Notice is hereby given that the East Sussex County Council, as local planning authority, in pursuance of the powers conferred on them by section 1 of the Civic Amenities Act 1967, have designated the land described in the Schedule to this notice as Conservation Areas. The effect of this designation is to define the below-mentioned areas as of special architectural or historic interest the character or appearance of which it is desirable to preserve or enhance and to require special attention to be paid to the character and appearance of the areas in the exercise of functions under the Town and Country Planning Act 1962, the Local Authorities (Historic Buildings) Act 1962, and the Historic Buildings and Ancient Monuments Act 1953.
