The Borough of St. Austell with Fowey (Church Street and East Hill, St. Austell) (One-Way Traffic) Order, 1969.

SOUTHPORT COUNTY BOROUGH COUNCIL

The County Borough of Southport (Shakespeare Street) (Prohibition and Restriction of Waiting) Order, 1969.

Notice is hereby given that the Southport County Borough Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which will be to (a) prohibit the waiting of vehicles at all times on the south-easterly side of Shakespeare Street between its junction with Portland Street and its junction with Duke Street, and (b) restrict waiting of vehicles on the North-Westerly side of the same length of road between the hours of 9 a.m. and 6.30 p.m. to one hour in any period of two hours.
