## Nature of the objection

That the expression "mainly for hire or reward" used in paragraph 1 (1) of the Schedule to the draft Order is too imprecise and should be replaced by the expression "for hire or reward to any extent or on any occasion" with the consequent deletion of paragraph 1 (2).

That paragraph 2 (3) of the Schedule to the draft Order, which excludes from the scope of the Order the carriage or haulage of goods by a company which carries goods exclusively for another company or other companies associated with it, is too wide in that its effect will be to exclude not only those undertakings at present so engaged which operate solely on "C" licences but also similar undertakings which operate on "A" or "B" licences.
