#### LEICESTER CITY COUNCIL

*The Leicester Traffic Regulation Order 1969—  
Amendment*

Notice is hereby given that the Leicester City Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, the effect of which will be to:

- (1) prohibit waiting and loading and unloading at all times on the west side of Fosse Road North between Tetuan Road and Pool Road (i.e. the bus layby);
- (2) prohibit waiting at all times and loading and unloading from 8 a.m. to 9.30 a.m. and from 5 p.m. to 6.30 p.m. on weekdays in lengths of Fosse Road North, Henley Road and Paget Road (i.e. at the junction), and in lengths of Glenfield Road, Henley Road and Woodville Road (i.e. at the junction);
- (3) extend the prohibition on waiting at all times and loading and unloading between 8 a.m. and 9.30 a.m. and between 5 p.m. and 6.30 p.m. on Glenfield Road, to the west of Fosse Road North, by 17 yards;
- (4) prohibit waiting at all times in lengths of Glenfield Road, Gimson Road and Sandhurst Road (i.e. at the junction);
- (5) prohibit waiting from 8 a.m. to 6.30 p.m. and loading and unloading from 8 a.m. to 9.30 a.m. and from 5 p.m. to 6.30 p.m. on weekdays in lengths of Glenfield Road and Henley Road;
- (6) prohibit waiting from 8 a.m. to 6.30 p.m. on weekdays in a length of Carlisle Street (i.e. near its junction with Glenfield Road), and on the north side of Glenfield Road;
- (7) make Paget Road one-way between Fosse Road North and Tyrrell Street in that direction.

A copy of the proposed Order and a map showing the roads to which the proposed Order relates and a copy of the authority's statement of reasons for proposing to make the Order can be inspected at the Town Hall at all reasonable hours from Monday to Friday inclusive.

Objections to the proposals, together with the grounds on which they are made must be sent in writing to the undersigned by 8th July 1969.
