Borough of Droitwich Footpath No. 26 Public Path Extinguishment Order, 1969

Stopping Up of a Length of Deyes Lane/School Lane, Maghull

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

Rural District Council of Malling (Footpath No. 427 (Part) Ightham) Public Path Diversion Order, 1968

Notice is hereby given that on the 11th day of June 1969 the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect will be to divert the public right of way at Doles Cottage, Ivy Hatch in the Parish of Ightham running from a point on the western side of Ismays Road on the northern side of Yew Tree Cottage to a point at approximately 130 feet southwest therefrom, to a line running from a point approximately 43 feet due north from the said point in Ismays Road and leading in a west-south-westerly direction for approximately 107 feet and thence in a south-south-westerly direction for approximately 75 feet to join Footpath No. 427 at the same finishing point. The path to be diverted will be closed at the expiration of nine weeks from the date of confirmation of the Order, namely the 22nd day of August 1969.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Council Offices, High Street, West Malling, Kent, between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays.

The Order becomes operative as from the 20th day of June 1969 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act, or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.
