

THE IMPORTED FOOD REGULATIONS, 1968

Argentine Republic: Official Certificate

The Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on him by the Imported Food Regulations 1968 he hereby varies the recognition of the Official Certificates reproduced in (1) and (2) of the Schedule to the notice published in the *London Gazette* dated 15th March 1938, design 2 in the Schedule to the notice published in the *London Gazette* dated 11th March 1952 and designs 1, 2 and 3 in the Schedule to the notice published in the *London Gazette* dated 7th July 1964, for the importation of meat and meat products; and the Official Certificates reproduced in Part II of the First Schedule to the notice published in the *London Gazette* dated 25th October 1968 for the importation of horsemeat and horsemeat products from the Argentine Republic, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 20th May 1969 is hereby revoked.

SCHEDULE

In relation to horsemeat and horsemeat products recognition is restricted to Certificates of the designs reproduced in the First Schedule to the notice published in the *London Gazette* of 25th October 1968, which are completed by the insertion of one of the following establishment numbers:
