## WATER RESOURCES ACT, 1963

### *Lincolnshire River Authority*

In pursuance of section 11 (6) (a) of the Water Resources Act, 1963, the Minister of Agriculture, Fisheries and Food hereby gives notice that the Lincolnshire River Authority have made an application for the variation of the main river map of their area.

Short descriptions of the proposals are set out below. The effect will be to bring the added watercourses under the Lincolnshire River Authority's jurisdiction for land drainage and flood prevention purposes; the watercourse deleted will be freed from this jurisdiction.

#### *Additions*

1. A diversion of Spring Dike, from Castlethorpe, Broughton Parish to the River Ancholme, including two new channels to be cut.

2. A watercourse known in part as Orford Beck from its junction with Kirmond le Mire Beck near Black Holt, Binbrook Parish and flowing through Orford, Swinhope, Thorganby and Hatcliffe to existing main river near Hatcliffe Mill, at Barton Street, B.1431, including a new channel to be cut near Priory Farm, Stainton le Vale Parish.

3. The Tetney Catchwater, being for the most part new channels to be cut, from a point on the boundary between the Holton le Clay and Tetney Parishes, south of Holton Grange to a confluence with Tetney Drain south of Tetney.

4. Part of Sambre Beck, from the Stainfield-Langworth road to existing main river near the Marsh Drain, Stainfield Parish.

5. Part of Stainfield Beck, from Stainfield to existing main river near Stainfield Grange, Stainfield Parish.

6. A tributary of the River Bain, from a point near Blackhouse Farm, Hemingby, to a confluence with the River Bain via a new outfall still to be cut near the boundary between Hemingby and West Ashby Parishes.

7. Part of Woodhall Sewer, from a point south of Kirkstead to its confluence with the River Witham.

8. Part of Kirkstead Mill Beck, from a point north of Mill Farm, Kirkstead Parish, to its confluence with the River Witham.

9. A short length of the River Witham north-west of South Witham.

10. Part of Folkingham Beck and Ouse Mere Lode, from a point upstream of Mareham Lane, Folkingham Parish to existing main river near Billingborough.

#### *Deletion*

11. Part of West Drain from a point near Castlethorpe to the confluence with Ella Beck, Broughton Common, Broughton Parish.
