PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and Incomes of the pay and conditions of workers employed in the milk products manufacturing and milk distributive industries in Great Britain.

The Government consider that an examination should be made of pay and conditions of workers employed in the milk industries with a view to encouraging higher levels of efficiency and productivity.

Accordingly, the First Secretary of State and Secretary of State for Employment and Productivity Secretary of State for Employment and Productivity, acting in pursuance of her powers under section 2 (1) of the Prices and Incomes Act 1966, hereby refers to the National Board for Prices and Incomes, for their examination and report, the pay and other terms and conditions of employment of workers employed in Great Britain in the collection of milk, the manufacture of milk products and the processing and distribution of milk and distribution of milk.

DRAFT SPECIAL REGULATIONS

Factories Act 1961

In pursuance of section 180 of, and Schedule 4 to the Factories Act 1961, the Secretary of State for Employment and Productivity hereby gives notice that she proposes to make special regulations making that she proposes to make special regulations making provision for the protection of the eyes of persons in factories and certain other premises and places to which the Factories Act 1961 applies while carrying on any of the processes which are specified in Schedule I to the Regulations. They require the provision for those persons of eye protectors or screens, other than face screens. While electric welding is being carried on the Regulations require the privision of helmets, head shields or hand shields for persons employed in it and of screens or eye protectors for other persons employed in positions where rays from the welding are likely to be injurious to their eyes. injurious to their eyes.

Eye protectors are required to conform with specifications approved by the Chief Inspector of Factories.

The Regulations supersede the Protection of Eyes Regulations 1938, and certain provisions requiring the provision of goggles or other means of protection contained in the Chemical Works Regulations 1922, the Iron and Steel Foundries Regulations 1953, the Shipbuilding and Shiprepairing Regulations 1960 and the Non-Ferrous Metals (Melting and Founding) Regulations 1962.
