The Import Duty Drawbacks (No. 1) Order, 1969

This Order—

- (1) revokes the provisions for the allowance of drawback of import duty on hats, etc. manufactured from imported hatters' fur; and
- (2) revokes the existing fixed rate of drawback of import duty in respect of exported plywood packing cases and provides for drawback to be related to the duty paid on the imported plywood actually used in their manufacture.

TOWN AND COUNTRY PLANNING ACT 1962

HIGHWAYS ACT 1959

The London—Fishguard Trunk Road (Ffynnon Bridge, near Commercial) Order 1969

The Secretary of State hereby gives notice that he has made an Order under section 7 of the above Act providing:

- (a) that a road which he proposes to construct at Ffynnon Bridge, near Commercial in the County of Pembrokeshire shall become a trunk road as from the date when the Order comes into operation, and
- (b) that the length of the London—Fishguard Trunk Road to be superseded shall cease to be a trunk road as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of Pembrokeshire (who will become the highway authority responsible for that length) that the new trunk road is open for through traffic.
