### WATER RESOURCES ACT 1963

Somerset River Authority

In pursuance of section 11(6)(a) of the Water Resources Act 1963, the Minister of Agriculture, Fisheries and Food hereby gives notice that the Somerset River Authority have made an application for the variation of the main river map of their area.

Short descriptions of the proposals are set out below. The effect will be to bring the added watercourses under the Somerset River Authority's jurisdiction for land drainage and flood prevention purposes.

Additions

- Matercourses known in part as Chedzoy New Cut, from Park Wall Rhyne to King's Sedgenoor Drain in the Parish of Chedzoy, together with watercourses known in part as Double Bridge Rhyne, Penzoy Rhyne, Lake Wall Rhyne and Little Drove Rhyne, from Chedzoy New Cut to Westonzoyland Engine Rhyne in the Parish of Westonzoyland, all in Bridgwater R.D.
- 2. A watercourse from Little Burrow Drove Rhyne (Westonzoyland Engine Rhyne) to Burrow Wall Rhyne in the Parish of Othery, Bridgwater R.D.
- 3. Wateroourses known in part as Burrow Hill Drove Rhyne, Cross Rhyne and Cut Drove Rhyne, from Southlake Engine Rhyne to Challis Wall Rhyne in the Parish of Othery, Bridgwater R.D. and the Parish of Aller, Langport R.D.
- 4. Witcombe Bottom Main Drain, comprising existing watercourses and new channels still to be cut.

Tintinhull, Ash and Long Load, Yeovil R.D., together with King's Moor Main Drain, comprising the watercourses known as Main Drain and a new channel still to be cut, from a point near Row Moor and thence under the River Yeo to join Witcombe Bottom Main Drain near Long Load, all in the Parish of Long Sutton, Langport R.D. and the Parish of Ash, Yeovil R.D.
