### MONMOUTHSHIRE COUNTY COUNCIL

#### TOWN AND COUNTRY PLANNING ACT 1968 SECTION 94

#### *Monmouthshire County Council F.P. No. 92 Stopping-Up Order 1969*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 30th day of July 1969, is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the County Council of the Administrative County of Monmouth as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to extinguish the public right of way F.P. 92 from its junction with the County Class III Road (Route S.341-1) near Ivy Cottage, Croesyceiliog in an easterly direction to its junction with the Trunk Road (Route A.4042) as shown marked A-B on the plan attached to the Order.

A copy of the Order and the map contained in it has been deposited at the Pontypool Rural District Council Offices, Usk, at the offices of the Cwmbran Development Corporation, Victoria Street, Cwmbran and at the County Hall, Newport, and may be inspected free of charge at those offices between the hours of 9 a.m. and 5 p.m. on weekdays (Saturday excluded).

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Monmouthshire County Council, County Hall, Newport, Mon., not later than the 11th September 1969 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn the County Council may, instead of submitting the Order to the Secretary of State for Wales for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

#### *Westerhope/West Denton Comprehensive Development Area*

Notice is hereby given that on the 31st January 1969, the Minister of Housing and Local Government amended the above Development Plan.

Certified copies of the amended Development Plan together with a statement of rights of appeal to the High Court, have been deposited at the County Hall, Newcastle upon Tyne and at the offices of the Newburn Urban District Council, Council Offices, Newburn on Tyne.

The copies of the Development Plan, and accompanying statement, so deposited will be open for inspection free of charge by all persons interested at the places mentioned above between the hours of 9 a.m. and 5 p.m. on Mondays to Fridays inclusive.

The amendment becomes operative as from the 2nd August 1969, but if any person aggrieved by it desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1962, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the making of the amendment he may, within six weeks from the 2nd August 1969, make application to the High Court.

The proposals dealt with in the amendment comprise the comprehensive development of approximately 228 acres of land situated between Westerhope and West Denton in the Urban District of Newburn, and amend and supercede the existing scheme for

this area which became operative on the 27th November 1962.
