The part of the path to be extinguished will be replaced by an alternative section of bridleway which will be created as part of the South Downs Long Distance Route when this Order takes effect and an alternative way will be provided from a point immediately to the north of the entrance to the Pyecombe Golf Club to the easterly limit of the section of bridleway to be extinguished.

A copy of the Order and the map contained in it has been deposited at and may be inspected free of charge at the offices of the Cuckfield Rural District Council, 35 Boltro Road, Haywards Heath, between the hours of 9 a.m. and 12 noon and 2 p.m. and 5 p.m. on any weekday except Saturday and also at Pyecombe Post Office.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Cuckfield Rural District Council at the Rural Council Offices, 35 Boltro Road, Haywards Heath, before the 8th September 1969, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Cuckfield Rural District Council may instead of submitting the Order to the Minister of Housing and Local Government, themselves confirm the Order. If the Order is submitted to the Minister any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

Proposed Closure of Parts of Road A.68 and Part of Road A.6072 at Burtree Gate

Notice is hereby given that the County Council of Durham intend to apply to the Magistrates of the Darlington County Petty Sessional Division sitting at the Magistrates' Court, Parkgate, Darlington, on Monday the 8th day of September 1969, at 10.30 a.m. for an Order authorising the closure of parts of road A.68 and an adjoining part of Road A.6072 at the Motorway Interchange at Burtree Gate in the Parish of Coatham Mundeville in the Rural District of Darlington.

The said Road A.68 extends from Darlington to West Auckland and beyond and the said Road A.6072 extends from Shildon to the junction with the above-named Road A.68. The closures are required in consequence of the improvement of Road A.68 and the junction with Road A.6072 near the Motorway Interchange.

The parts to be closed are as follows:

- (1) That section of Road A.68, 634 yards or thereabouts in length, extending from the junction with the new part, approximately 100 yards south of the entrance to Humbleton northwards to rejoin the new part (A-B on the deposited plan).
- (2) That section of Road A.68, 483 yards or thereabouts in length, extending from the junction with the new parts, approximately 70 yards north of the entrance to Swan House, northwards to a point opposite the roundabout (C-D on the deposited plan).
- (3) That section of Road A.6072, 370 yards or thereabouts in length, extending from the junction with the new parts of Road A.68 opposite the former junction with the old Road A.68 northwards to rejoin the new part, north of the roundabout.
