The County Council of Durham (Various Streets, Horden) (Prohibition of Waiting) Order 1969

Notice is hereby given that the County Council of Durham have made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is:

- (a) to prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. including a ban on the loading and unloading of vehicles in the lengths of roads specified in the First Schedule hereto; and
