### ROAD TRAFFIC REGULATION ACT

*The Trunk Road (Fletchamstead and Kenpas Highways Junctions with Cannon Close and Wainbody Avenue, Coventry) (Prohibition of Driving) Order 1969.*

1. A public inquiry will be held by Mr. T. A. Shurlock in the Council Chamber, Council Offices, Earl Street, Coventry, commencing at 10.30 a.m. on Wednesday, 3rd September to consider the proposal of the Minister of Transport to make the above named Order. The effect of this Order will be to prohibit the driving of any vehicle:

(a) from the north-eastern carriageway to the south-western carriageway; or

(b) from the south-western carriageway to the north-eastern carriageway,

through the gap in the central reservation of the London—Holyhead Trunk Road (A.45), known as Fletchamstead Highway in the city of Coventry, at its junction with the north-western arm of Cannon Close or, through the gap of that length of the said Trunk Road, known as Kenpas Highway in the city of Coventry, at its junction with Wainbody Avenue.

2. Any person interested is entitled to be heard in person or by Counsel, Solicitor or Agent and any person whether he intends to appear at the inquiry or not may forward any objection to the proposal to Mr. Shurlock, care of the Divisional Road Engineer, Five Ways House, Islington Road, Edgbaston, Birmingham 15.
